### Atlanta Land Trust Advocacy Work - COVID-19

ALT joined housing advocates, lawyers, and law professors to request that Governor Kemp issue an Executive Order suspending evictions and foreclosures in response to the COVID-19 crisis. The duration of the proposed moratorium will correspond with the statewide shelter-in-place Order issued by Governor Kemp on March 23, 2020. ALT also joined other mission-driven housing developers in asking the City of Atlanta to set up an emergency housing assistance fund.

### Mortgage Payment Assistance

Many banks have announced suspension of foreclosure activity. If your mortgage is owned by Fannie Mae or Freddie Mac, <u>hardship forbearance is an option</u> for those who are unable to make their monthly mortgage payments due to the novel coronavirus. Your mortgage servicer would be able to determine your eligibility for such mortgage payment relief. Furthermore, on March 18 the Federal Housing Administration (FHA) implemented a <u>60-day foreclosure and eviction moratorium for single family homeowners</u> with FHA-insured mortgages.

According to the Federal Housing Finance Agency (FHFA), if you have been impacted by the Coronavirus, if your mortgage is underwater or your property threatened by foreclosure, you may find the information in <a href="Mortgage Assistance">Mortgage Assistance</a> helpful. If you are purchasing a property or trying to navigate the financial housing market, visit <a href="Mortgage Education">Mortgage Education</a> for information from shopping for a mortgage to avoiding scams and federal resources.

### Rental Assistance

Organizations like <u>Giving Kitchen</u> allow food service workers to apply for assistance in times of strife, although with such a widespread illness, their resources are spread thin.

Additionally, Mayor Keisha Lance Bottoms issued an executive order calling on all public agencies to institute a temporary moratorium on residential evictions and filings for a period of sixty days beginning March 17.

On April 7 Mayor Keisha Lance Bottoms and <u>Atlanta Housing (AH)</u> CEO Eugene Jones, Jr. announced rent relief efforts for individuals who live in AH-owned or subsidized units and have lost income as a result of the COVID-19 pandemic including Housing Choice Voucher Program participants. ### **Water and Sewer Services**

As of March 11, the <u>Department of Watershed Management will suspend service termination for 60-days</u>. To learn more about their resources residents can call 404-546-0311.

### Georgia Power

As of March 14, Georgia Power will temporarily suspended residential and business disconnections as a result of COVID-19. Visit GA Power's website for current GA Power service termination updates.

### Natural Gas Services

### Small Business Support and Loans

Invest Atlanta created a Business Continuity Loan Fund.
